3. Minutes of Spring 2021 Synod Meeting

7. **Proposed Members Resolution**

Gethin Rhys introduced the resolution and took questions with Martha McInnes, as seconder to the resolution, offering support.

Simon Walkling clarified that the Charity Commission had stated that everyone has an interest to declare on this issue, and therefore everyone can be involved in the discussion and decision-making process.

Questions were taken from the floor and were answered by Gethin Rhys and Simon Walkling. These questions related to the cost of a pensions scheme, the influence of the market, and the next steps.

A positive consensus was reached and the resolution was passed.

Synod Meeting, noting the decision in principle of the General Assembly to move away from a Defined Benefits pension scheme for ministers, requests those working on a replacement scheme to ensure that the Church puts in place a suitable form of financial safety net, funded by the Church, to underpin a minimum fair pension for all ministers at retirement.
